Rabbits Foot - The name says it all! You will need to play well and hope for a little luck on this course. Rabbits Foot offers a woody, pastoral setting measuring 6,740 yards from the tips and features 61 greenside and fairway bunkers. Water comes into play on 13 holes, including an island green.
